Discounts & Scholarships 2020-2021

Mt. Carmel Christian Academy offerings the following tuition discounts and scholarships to qualifying students. Students that qualify for multiple discounts/scholarships will receive the highest one for which they qualify. Discounts/scholarships may not be stacked. Discounts and scholarships may only be awarded to K-5 - 12th grade students.

Shepherds Scholarship: Because we value our partnership with Bible-believing churches in the area, MCCA is offering pastors the opportunity to receive a 50% tuition discount off their families' full tuition.

Legacy Discount: MCCA full-time staff members are eligible to receive a 50% tuition waiver for any grandchild that they have enrolled at MCCA.

MCRBC Membership Scholarship: Members of our MCRBC family who invest in a Christian education for their child(ren) will receive a 10% tuition discount for each child that they have enrolled.

Alumni Scholarship: A student whose parent is a graduate of MCCA will receive a \$500 discount per year (one per family only).

Kindergarten Scholarship: Current MCCA preschool families enrolling their child in kindergarten will receive a \$500 discount.

New Family Referral Credit: Current MCCA families that refer MCCA to a family that enrolls one or more new students will receive a tuition credit of \$500 per family for up to three families. The referring family may opt to transfer the credit to the new family as a gift towards their tuition expense.
